

August 14, 2018 - Superintendent's Report ADMIN UPDATE:

The Utility is seeking approval for the following DRF's related to our State Revolving Fund loan projects:

DRF 45 - Tank Industry Consultants \$30,761.00 for engineering and inspection services related to the Oaklandon Tower Project. These fees have been paid by the utility already and this DRF is needed so we can be reimbursed via our SRF loan.

The Oaklandon Tower is now filled and back in service. Remaining work includes fence installation, site restoration and touch-up painting after T-Mobile completes relocating their comm gear onto the tower.

DRF 46 – Graves Plumbing \$221,209.00 for construction work on the Richardt WTP Project Wessler related to Pay Application #12.

This project is fast nearing completion and we are also seeking approval of a Change Order this evening per a previous explanatory email sent to you all. In summary, the additional work of the bulk bleach storage building, floor drains in the well houses, phosphate feed equipment and lighting installation is recommended for approval. Please note that the final CO amount is somewhat higher than the \$58,611.71 previously provided as the electrical part of the bulk bleach building was omitted.

DRF 47 – Wessler Engineering services related to our Phase I improvements and includes design and bid phase work on the well field improvements as well as construction inspection and admin on the Richardt WTP project.

The Utility also issued a water and sanitary sewer availability letter for Meyer Plastics, which is building a new facility at 59th & Sunnyside Road.

There are no other major items of note to report at this time.
