Dear Utility Customer,

Franklin Road Water Main Replacement – the Utility will soon be awarding a contract to replace a section of old water main in Franklin Road from 45th Street north to 47th Street. This is part of a phased approach to eliminating all the old water main in Franklin Road, which work will continue in succeeding years. This work is planned to be completed this summer.

Shadeland Way Water Main Installation — the Utility will be awarding a contract to install a new water main along Shadeland Way from 56th Street to Mardyke Lane in order to complete a loop and eliminate the dead-end main on Mardyke as well as allow for the abandonment of an old water main at the Richardt Water Treatment Plant that feeds into the Edlou subdivision. This work will also be completed this summer.

Brookhaven Water Main Replacements - The design phase is underway to begin the replacement of the old water mains in this subdivision, which experiences frequent main failures and rusty water complaints. The work is anticipated to be bid in the latter part of the fall with construction starting in spring 2020. The first sections will be along Kitley Avenue from 46th to 52nd and then moving east into the subdivision. More information as to the exact areas will be provided as they become available. New mains will be installed and old mains abandoned, new service lines, meter pits and curb stops will also be a part of the project. We have changed the installation plan

from its first proposed layout after discussion with our engineers.

47th Street Water Main Replacement Project - This project includes old main abandonment in Richardt from 47th to 46th, 47th Street, Payton Street from 47th to 48th and work on all the side streets and dead-end streets south and north of 47th between Richardt & Franklin Road, New mains will be installed and old mains abandoned, new service lines, meter pits and curb stops will also be a part of the project. Plans are at 90% completion now and we anticipate bidding in June and awarding project in July and plan on completion this summer and perhaps into the fall.

Carroll Road Water Main Installation and East 62nd Street Water Main Installation – these two projects, designed to provide fire protection in areas that presently do not have fire hydrants and eliminate dead-ends as well as make city water available, are still in the easement acquisition phase, although we hope to get the Carroll Road water main installed yet this year.

Sewage Lift Station 19 Replacement – This lift station project has been awarded and we anticipate starting construction in mid-June. This is not a moment too soon as this station experienced a major failure on May 27th.

Design is also continuing on the 2019 Sewer Main & Manhole Rehabilitation Project, for which we are applying to the Office of Community & Rural Affairs (OCRA) for

a grant to supplement our existing sewer capital funds to be able to do more work. This work will be concentrated in the area between Shadeland and I-465 and from 46th Street to the CSX tracks. This work will likely be bid in the Fall of 2019 with completion in the Spring of 2020. THE UTILITY IS STILL SEEKING LETTERS FROM OUR CUSTOMERS IN THIS AREA SUPPORTING OUR APPLICATION TO **RECEIVE** THIS ADDITIONAL FUNDING.
