# CITY OF LAWRENCE Police Merit Commission March 9, 2020 Regular Meeting

Commission President Wheeler called the meeting to order at 6:00 p.m. and announced a quorum was present.

#### COMMENTS OF COMMISSION MEMBERS: None

<u>APPROVAL OF MINUTES</u>: Ms. Powers moved to approve the minutes of the regular meeting on February 10, 2020. The motion was seconded by Mrs. Gartin and carried 3-0.

## UNFINISHED BUSINESS: None

**NEW BUSINESS:** Deputy Police Chief Woodruff requested that the Professional Standard Division Commander be the acting Agent for the Police Merit Commission in accepting completed applications for the 2020 hiring process. Following discussion, Mrs. Gartin moved to approve Captain Schneider to act as the agent for the Police Merit Commission for the 2020 hiring process. The motion was seconded by Ms. Powers and carried 3-0.

Deputy Chief Woodruff recommended Testing for Public Safety Personnel, LLC dba IPSP for contracted services aptitude testing (written exam and oral interview). Ms. Powers moved to approve IPSP for contracted services aptitude testing (written exam and oral interview). The motion was seconded by Mrs. Gartin and carried 3-0.

PERFORMANCE RECOGNITION: Deputy Police Chief Woodruff invited Officer Anthony Stout to join him at the podium. Deputy Police Chief Woodruff informed the Commission of the actions by Officer Anthony Stout and Officer Stuart Bishop on January 12, 2020 just after 7:15 p.m. (Officer Bishop was unable to attend the Commission meeting.) Both officers responded to the strip mall at 8015 Pendleton Pike where 2 individuals had been shot in an apparent robbery attempt at a business there. After stabilizing the scene, both officers applied tourniquet dressings to both gunshot victims, effectively controlling additional blood loss. Their actions likely served as life-saving measures. The tourniquet kits the officers employed are supplied to police departments across central Indiana by the Central Indiana Police Foundation and through the generosity of many donors in the community. The specifics of the actions by Officer Stout and Officer Bishop are contained in the Chief's attached comments. After his comments, Deputy Police Chief Woodruff presented a Police Merit Commission certificate of recognition to Officer Stout and Officer Bishop.

ADMINISTRATION COMMENTS: Deputy Police Chief Woodruff announced that the next "Community Shred Day" will be held on April 25, 2020 from 10am to 1pm at Belzer Middle School.
