

# **April 14, 2020 – Superintendent's Report** ADMIN UPDATE:

Utility Operations continue to be in "Coronavirus Mode", and as you are all aware, the stay home/work from home directive has been extended to April 20. Thankfully, there are no reports of LU employees or their families being stricken with the virus at this time.

Our Franklin Road and 47<sup>th</sup> Street water main projects are just about completed, with only Punchlist items remaining for Franklin Road and the paving & restoration work for the 47<sup>th</sup> Street project.

There will be a final change order for Franklin Road which we will need to have approved. This CO, for roughly \$85,000 includes numerous added items we discovered during the course of the project as well as additional paving costs, which make up the bulk of the CO cost. Although Midwest Mole's asphalt unit prices were considered high, we opted to keep the paving with them in order to get Franklin Road opened back up sooner. This CO will be presented for approval at the April 28<sup>th</sup> meeting, but I wanted to let you know about it at this meeting so I can answer any questions you might have prior to the April 28<sup>th</sup> meeting.

At the April 28<sup>th</sup> meeting we also hope to have the final pay application for the Wellfield Improvements Project submitted for approval. The contractor should have completed the Punchlist items and be ready to close out the project.
