SECTION 2. Wages and/or salaries as set by this resolution provide for a range including a maximum amount of compensation for each position as authorized by this resolution.

SECTION 3. All annual and hourly salaries as established in this resolution shall be paid semi-monthly.

SECTION 4. Each utility employee shall be entitled to an automatic annual increase of \$100.00 for each year of full-time service, subject to yearly review by the Utility Service Board, provided, however, that this automatic annual increase shall not be due and payable until the completion of two (2) years of service to the City.

SECTION 5. Each eligible utility employee shall be entitled to certain insurance and other benefits. For a complete outline of benefits for eligible employees, see the City of Lawrence Employee Handbook and the Employee Benefits Enrollment Guide for the Plan Year January 1, 2025 – December 31, 2025 ("Benefits"), which are hereby expressly incorporated by reference. These Benefits are in addition to the above wages and salaries set forth in this resolution.

SECTION 6. Each utility employee shall be entitled to college incentive pay (at the hourly rate of \$.12 per hour for one year (30 credit hours), \$.24 per hour for two years (60 credit hours), \$.36 per hour for three years (90 credit hours), \$.48 per hour for one college bachelor's degree, and \$.72 per hour for a master's degree upon satisfactory documentation of such credit hours and degrees.
