ADMIN UPDATE:

The Utility is seeking approval tonight for:

DRF #26 – Graves Plumbing (RWTP Project) Pay Application #5 for \$190,856.00 DRF #27 – Finch Constructors (Sumac WM Project) Pay Application #2 for \$29,306.00

The Richardt WTP project will be resuming activity next week and the Sumac project is completed except for some minor punch-list items.

The Utility is working on putting together pricing for replacement vehicles for both the water and sanitary sewer operations and we hope to have this part of our capital improvements program completed prior to the first quarter. The Utility has many old vehicles in poor condition and as these vehicles are crucial to our being able to successfully and reliably perform our various operations and maintenance activities. These purchases are included in the capital improvements portion of our 2018 Budget.

The Utility will also be working on putting together pricing for other water system improvement work such as water main valve and hydrant work, meter pit installations, large meter testing work along with continuing to move forward on our Phase I PER projects, namely Oaklandon Tower and the Fort Harrison/Indian Lake Well Field Improvements Projects.

The Utility will also see the completion of the 2017 Sanitary Sewer Manhole Rehabilitation Project and the commencement of the Trades District Sanitary Sewer Improvements Project. In addition, we will be working towards addressing issues with Lift Station 19 and hope to bid this project later in the year. We are also working on plans to address sanitary sewer issues in conjunction with the DPW's upcoming 47th & Richardt Drainage Improvements Project, which is presently in design.
