



## April 24, 2018 – Superintendent’s Report

### ADMIN UPDATE:

The Utility is seeking approval of a general water line construction observation agreement for the new Discount Tire project that is being built at 10032 Pendleton Pike. This is a standard agreement that allows us to be compensated for our inspection time and activities.

The contractor is fully mobilized at Oaklandon Tower now and some structural work has already been completed.



In addition, the Richardt WTP project is making great progress with the new filters being set in place along with the emergency generator.

The CIPP part of the Trades District has been completed with the remaining work items being completion of the service lateral linings and the new 8-inch sewer installation along Allen Street. The Manhole Rehabilitation Project is about 90% complete and we look forward to completion by end of April or early May.

The Sumac Water Main contractor has notified us of completion on April 16<sup>th</sup> and we have signed off on the remaining work items and the final project payment and closing documentation paperwork is in process.

The Well Field Improvements Project is at 100% plan completion. We are now going over bid advertising/opening schedule along with other bid-phase activities with the engineer.

Change Order #3 for the painting of the well houses at Richardt, which are also being structurally repaired, is submitted for approval. This increase in cost does not raise the construction costs above the original contract amount. We recommend approval.
