

# July 24, 2018 – Superintendent's Report **ADMIN UPDATE:**

All Utility projects are proceeding without problem with the exception of the Oaklandon Tower. There was a problem with the paint curing properly on the basket and figures due to the logo painter getting the mix wrong. The nature of the high-quality paint being used requires an accurate mixing of two components and this was not achieved for the parts mentioned. This resulted in their having to remove the gondola/basket painting and the 4 children figures and then repainting. This has pushed completion back to approximately July 27. There is no additional cost to the utility for this work. It does show why having high-quality inspection on these projects is important too.

Revised DRF 34 is on the agenda tonight. An error in the math was made and the engineer corrected it and, rather than void the old DRF and issue a new one, SRF instructed us to revise DRF 34 with the corrected number, which is \$1,492.00 less than the original amount.

DRF's 43 and 44 are also on the agenda for approval and we recommend approval. With the payment of DRF's 34 (R) and 44, the Sumac Water Main project will be closed out.

The Utility staff is working on preparing and submitting the Annual Utilization Report for the Fort Harrison water treatment plant, an annual requirement associated with the turnover of that facility to the city back in 1996. We have also just submitted our 5 year update to the Wellhead Protection Phase II plan, another required report.

There are no other items of note to report.
