

August 13, 2019 - Superintendent's Report ADMIN UPDATE:

Utility management is seeking approval of the award of the 46^{th} Street Water Main Extension project to Poindexter Excavating in the amount of \$65,589.00. Poindexter was the lowest, most responsive and responsible of the two quotes received. This is the project that entails the installation of 330 feet of 10-inch water main across 11302 & 11240 E 46^{th} Street and provide service to those addresses. This project will be funded out of water capital funds. A copy of the quote was included in your packets.

Utility management is seeking approval for purchase of a water main easement for 12320 East 62nd Street to move us further toward getting that water main extension project underway.

Utility management is seeking approval of the award of the 47th Street Water Main Project to Miller Pipeline upon the recommendation from Wessler Engineering in the amount of \$1,796,868.47 from the bids that were opened at the USB Special Meeting on August 6, 2019. Miller Pipeline was the lowest, most responsive and responsible bidder of the two bids that were opened. The certified bid tabulation, recommendation of award letter, and notice of award paperwork was included in your packets.
