

# September 10, 2019 - Superintendent's Report ADMIN UPDATE:

The Utility Management is requesting approval of the Franklin Road Water Main Replacement Project per the recommendation of our Project Engineer Renee Goff with Shrewsberry Engineering. The bid from TSW was disqualified due to failure to acknowledge Addendum 2, making their bid unresponsive. Although the bid from Midwest Mole was higher than the engineer's estimate, in discussion with Renee we do not believe that we will receive any better pricing if we decide to re-bid the project. Also, with respect to timing, we want to be sure this project is completed prior to our contractor on the  $47^{th}$  Street water main replacement reaching Franklin Road on their project. That contractor (Miller Pipeline) has to complete the work at the Richardt Street end of  $47^{th}$  Street in order to be out of the way for the coming Stormwater Improvements Project by Indy DPW in Richardt Street and  $48^{th}$  Street east of Richardt to Mitchner.

We are also seeking approval of the final Change Order for the Richardt Street WTP project. This CO, for \$42,708.92, covers additional storm water and asphalt placement work that we requested that were not included during the original plans and also the installation of an electrical interlock to provide additional controls for Wells 1, 2 & 3 as well as High Service Pumps, 1, 2 & 3. This work will conclude the work on this plant and we will then begin the process to close out this project with SRF.

We would also like to advise the Board that Pay App #1 for the Lift Station 19 Project has been reviewed and approved by our engineer and Utility Management and is being processed for payment. Pay App #1 was for \$173,636.25. This project is moving along well and on-time and there are no issues of note.

We would also like to take the time to remind all our customers that the Fall Water Main Flushing has commenced. This work is scheduled to be done between September 3 and October 4, 2019. As a result of this activity, some customers may experience a temporary discoloration of their water and/or a low water pressure condition. Color can range from a light yellow to an orange-red. If this occurs, the customer should run a medium stream of cold water until the water clears. If a customer is experiencing this problem, the customer should not run hot water or wash clothes until the water clears up. The City does not reimburse customers for water used to flush their service lines due to iron discoloration. Main flushing is necessary in order to properly maintain the water distribution system and helps to improve water quality and maintain adequate disinfectant levels per regulatory requirements.
