

## IRRIGATION SYSTEMS

## PERMITS

In order to obtain permits for the installation or repair of an irrigation system an application, detailed drawings and a site plan must be submitted to the Department of Public Works (DPW). Plans must be neatly drawn and to scale (at least 1/8'' = 1 ft. min.) on  $11 \times 17$  paper (minimum).

Site plan must include:

- Any and all structures on the property including sidewalks and driveways;
- location of meter pit;
- location of irrigation tap;
- location PVB or RP;
- right of way and easement lines;
- location of sprinkler heads.
  - o If any part of the system is located within the right of way a right of way permit will be required
  - If any part of the system is located within the right of way the owner of the property will be required to submit a signed and notarized release of liability. This release must be received by DPW before permits can be issued.

Detailed drawing must include:


- Installation detail of PVB, include make and model of the proposed device;
- Installation detail for the irrigation tap;
- Meter pit detail.

## INSPECTION

- An inspection is required prior to backfill of the irrigation tap.
  - Contact Lawrence Utilities at 317-542-0511 to schedule inspection (provide 24-hour notice)
- A final inspection is required prior to putting the system into service.
  - The backflow test report must be submitted to Lawrence Utilities prior to the inspection. Email to <u>backflow@cityoflawrence.org</u>
  - o Contact Utilities at 317-542-0511 to schedule inspection (provide 24-hour notice)
