UTILITY WILL NO LONGER BE ACCEPTING PAYMENTS THROUGH PAYMENTUS

Dear Lawrence Utility Customer,

This month we would like to introduce a new feature that will soon be available to our customers, which is an electronic "Resume Service" form. We have received many requests to have this form available electronically so that customers do not have to come to the Business Office in person to fill out the form, which is our present practice. By executing this form, the customer is authorizing the Utility to turn the customer's water back on when there is no one present at the property. It informs the customer that, should a faucet, tap, spigot or other water-using appliance inside the home be inadvertently left on, the Utility will not be responsible for any water damage inside the home. It is our intention to "go live" with this feature starting in August.

Other information of note concerning utility bills is that effective September 1, 2019, the Utility will no longer be accepting payments through the "Paymentus" electronic bill pay service. If you are using Paymentus, you will want to make a note to switch to the other links for making electronic payment, such as recurring credit card payment, IVR or e-Check options.

As you are all aware, there has been a lot of rain this spring. Consequently, there have been a lot of drainage complaints. One type of complaint has been related to sump pump discharges. Sump pumps are privately owned and maintained pumps that serve to collect and remove water from homes and some businesses and are generally located in structures with basements. Sump pumps should discharge to a drainage feature such as a ditch, swale or storm sewer. In many subdivisions built since the late 80's, developers installed drainage tiles to provide for sump pump connections in those areas where homes with basements were being constructed. These are typically 4-inch plastic pipes with a tee connection for the sump pipe coming from the structure and are generally located in rear yard swales, although we have seen different configurations over the years. Sump pumps were, and are not now, permitted to be connected to street underdrain systems (a pipe located under the concrete curb in many streets in the newer portions of the city) unless this rule is waived in writing by the City. Sump pump systems serving private property are not the responsibility of the City to maintain or repair. However, the City's DPW inspectors will come out to help advise as to possible solutions and facilitate permitting issues if excavation work or taps into a city-controlled storm sewer pipe is necessary. While sump pumps are not directly mentioned in the city's Storm Water Ordinance, further underscoring the fact that these are not under the City's jurisdiction, there is language about how properties have to be properly drained and cannot cause negative impacts downstream.
