



NOTICE:

Our bill printing/mailing service made an error on the October 25th billing with the placement of the Utility's address on the remittance stub such that it will not appear correctly in the return envelope. Although the service provider offered to reprint and resend the bills, we felt this would only worsen the problem. Customers who are normally billed on the 25th should be aware that, should their payment be late, delayed or undeliverable due to this error with the printed and mailed bills, the Utility will not apply late fees or disconnect service for those affected by this error. On a lighter note, this does serve to point out that the On-Line Bill Pay option is a better and effective alternative to paper billings.

Utility Management and CFO Jason Fenwick are pleased to present our 2019 Water and Sanitary Sewer Budgets. The Water and Sewer Utilities look forward to continuing making improvements to your water and sanitary sewer infrastructure as well as improving our daily operations and management. We appreciate your continued support, cooperation and patience as we strive to turn things around to a pro-active, open and responsive approach. The challenges are great, but we have the people who are equal to the task. As we wrap up the last two Phase I Water System Improvements and our 2018 Sanitary Sewer Improvements Projects, we look forward to launching even more improvements projects in 2019 for both the Water and Sanitary Sewer Utilities.

Speaking of people, we have

a Sewer Utility laborer position open at the Utility. For this position, experience with sewage lift station operation and electrical experience is preferred, but not required. A Commercial Driver's License is required for both position. While experience is desired, we can and do train the right people. But the candidate should have at least some experience with basic hand tools, power tools and be willing and able to work in all kinds of weather and to work overtime, weekends and on-call shifts as needed for routine and emergency operations. This line of work is not for everyone! We want to find people who are interested in a career in a field that is interesting and challenging and a key component in maintaining the quality of life we enjoy in this country along with maintaining public health and safety. There is also an open position for a Building Code Inspector, and there will soon be a posting for a Street Department laborer, which will require a Commercial Driver's License as well.
