No person under eighteen (18) years of age shall be employed within any premises licensed under this chapter.

§4-2-5-5. LOCATION AND OPERATOR'S PERMIT FEES

(A) Each person, firm, or corporation which operates a massage parlor, massage therapy clinic, bathhouse, or any combination thereof or any school for teaching those skills shall pay an annual license fee of \$1,000.00 for each business location so licensed.

(B) Each person working within an establishment licensed under this chapter shall pay an annual operator's permit fee of \$500.00

§4-2-5-6. DENIAL OF PERMIT; RETURN OF FEE

In the even that a permit application is denied after investigation of the applicant by the Board of Public Works and Safety, 25% of the fee paid by the applicant shall be retained by the City to defray the costs of processing the application for the permit, and 75% shall be returned to the applicant.
