#### Minutes:

# b. Change Order #1, 2021 of Brandt Construction Pickle Ball Agreement:

The cost would be \$27,974 and that would be paid out of the Capital Improvement Funds. Jeff entertained a motion to approve the Change Order #1 with Brandt Construction. Motion was made by Tom Burns to accept the change, seconded by Helen Taylor. Motion carried 4-0.

### c. Resolution No.4, 2021:

Resolution No.4, 2021 is a budget transfer of \$105,000 for a new HVAC system at the Sterrett Center, curb and mulch at Alexander Park and remodel of the Community Center. Jeff entertained a motion to pass Resolution No.4, 2021. Motion was made by Amy Norman to accept the budget transfer, seconded by Helen Taylor. Motion carried 4-0.
