Eric informed the Board that our budget is very close in all accounts and we will have very little reserves as designed by the end of the year.

Carol stated that conversations were still being held between groups and another meetin tonight after the Park's Board meeting. LSC and FC Pride have until December 20, 2016 to vote for a dissolution or reinstatement of LSCI.

Old Business:

- a. Facility Usage Agreement for Fall Creek Softball and Baseball:
 - Courtney Perez with Fall Creek, asked for an amendment to the fees: They would like to do \$12,000 in kind rather than paying the \$4,500 in monies and \$4,500 in kind. Motion was made to table the agreement until financials were submitted. Motion carried 4-0.
- b. Facility Usage Agreement with Lawrence Township Football League:
 - Motion was made to table the agreement until financials were submitted. Motion carried 4 0.
- c. Facility Usage Agreement with Backyard BBQ:
 - After discussion, Carol Helmus made a motion to enter into the agreement with Backyard BBQ, seconded by Tom Burns. Motion carried 4-0.

- a. Facility Usage Agreement with Lawrence Lions Youth Baseball:
 - Agreement from March 1, 2017 through July 29, 2017
 - Rental fee of \$5,475.00 based on 365 kids at \$15 each.

 - Fees to equal 16 hours of volunteer services (2 hours per night of usage)

 - Agreement #2 Softball fields at Community Park on Mondays from 6pm 9pm
 - Dates July 10, 2017 through September 18, 2017
 - Fees to equal 20 hours of volunteer services (2hours per night of usage)
 - After discussion, Carol Helmus made a motion to enter into the agreement with Special Olympics Indiana, seconded by Tom Burns. Motion carried 4-0.
- c. Facility Usage Agreement with Lawrence Soccer Club for 2017:
 - Lawrence Soccer Club asked for amendments:
 - o Pay \$10.00 per kid rather than the \$15.00 per kid
 - o Tournaments fees to be lowered from \$100 per team to \$25.00 per team
