Meeting was called to order by Jeff Vest at 6:01 pm.

## **Minutes:**

Minutes of the August 10, 2016 meetings were distributed for review and clarification. Jeff entertained a motion to accept the minutes as submitted. Motion was made by Carol Helmus to accept the minutes, seconded by Tom Burns. Motion carried 5-0.

## **Reports from Parks Director:**

Eric informed the Board that there is a budget hearing Friday evening at 5pm at the Lawrence Government Center. The Park's Department has a proposed increase for 2017 for some remodel at the Community Center, and utilities being paid out of general budget instead of the non-reverting account.

## **Board Comment:**

Jeff asked if Eric had been any movement with Darrin Slack with Pro-Act about the community project at the Community Park. Eric has not heard from him.

## **Old Business:**

- a. Facility Usage Agreement for FC Pride Soccer Club – Tabled

- b. Facility Usage Agreement for Lawrence Soccer Club – Lawrence Soccer Club has paid their fees but no contract signed.

**New Business:**

- a. Facility Usage Agreement for Metropolitan School District of Lawrence Township – A couple of things that MSDLT would like in the agreement is:
  - Exclusive rights to field from March 1, 2017 to June 15, 2016
  - Green Barn year round for the batting cage
  - \$15,000 in kind

Jeff entertained a motion to enter into an agreement with Metropolitan School District of Lawrence Township with leaving the specifics to the attorneys to work out. Motion was made by Tom Burns to accept the agreement and seconded by Helen Taylor. Motion carried 5-0.

- b. Rental Refund request for Sterrett Center – August 6, 2016 by Savenne Hill

After discussion about the Sterrett Center, Jeff entertained a motion to refund half of the facility rental. Motion failed 1-4. Tom Burns entertained a motion to refund \$200 for compensation. Motion carried 4-1.
