

# March 12, 2019 – Superintendent's Report ADMIN UPDATE:

The Utility is seeking approval of the following:

Change Order #8 for the Richardt WTP Project – this CO is for cleaning of Well #3 and the addition of a new electronic actuator and pressure transmitter to resolve an issue with the filter backwashing process at the plant. Total cost = \$38,629.00

Change Order #01 for the Wellfield Improvements Project – This CO is to clean, televise and pump test Well #10 and for the additional rehabilitation work required for Well #10 structure related to masonry and concrete structural issues discovered in the field. Total cost is \$86,576.00

There is adequate funding remaining on the SRF Loan to cover these change orders.

The Utility is seeking approval of DRF 65 for Graves Plumbing in the amount of \$132,607.00 for work on the Richardt WTP.

The Utility management is seeking approval of Task Order 1 with American Structurepoint in the amount of \$60,700 for technical assistance related to the preparation of our OCRA Grant Application. This includes items such as the preparation of the Preliminary Engineering Report, updating project need, description and narrative descriptions, meeting attendance and a project budget/estimate.

The agreement with BLN for engineering services should be ready for the March 26th USB meeting.
