LeAndre states the Fire Chief also wanted to note to the Council that the Ambulance at Station #40 will be moving to another station for the next 10 days due to new flooring being installed. They should be back at Station #40 by January 18th.

He also states that DPW Director Jim Heneghan feels confident DPW is prepared for in the incoming mixed weather conditions this week. Communication will send out notice on when DPW will be deploying trucks into the communities.

LeAndre also informed the council that applications for the Ft. Ben Market went live today on our website until April 15th.
