<u>COMMENTS OF COUNCIL MEMBERS</u>: Councilor Wells thanked Utility Superintendent Salsbery and Deputy Controller Nagila for their prompt responses to his questions about the construction work on Richardt Street. He also thanked Mr. Nagila for reviewing a proposal.

<u>APPROVAL OF VOUCHERS 2-16-22</u>: Councilor Wells moved to approve Invoices [for vendors] as presented today [for \$361,932.19]. Councilor Denney seconded the motion. By a roll call vote, the motion to approve the vouchers carried unanimously.

<u>UNFINISHED BUSINESS</u>: Resolution No. 20, 2021, providing funding to the INSPIRE Program, was read only by title by Clerk Walton. Councilor Denney withdrew Resolution No. 20, 2021.

Resolution No. 21, 2021, providing funding to the "Laundry & More" Program, was read only by title by Clerk Walton. Councilor Denney withdrew Resolution No. 21, 2022.

Resolution No. 22, 2021, providing funding to the "Aktion Club" of the Kiwanis Club of Lawrence, was read only by title by Clerk Walton. Councilor Rusomaroff and Councilor Wells withdrew Resolution No. 22, 2021.

Resolution No. 1, 2022, adopt procedures for awarding community services grants from the Common Council of the City of Lawrence, Indiana, was read only by title by Clerk Walton. Councilor Chavis assigned Resolution No. 1, 2022 to the Committee of the Whole.

Resolution No. 2, 2022, concerning retention of Bose McKinney & Evans LLP as legal counsel, was read only by title by Clerk Walton. Councilor Denney said the Administration, Budget, and Finance Committee met and recommended approval of Resolution No. 2, 2022. The next Finance

Resolution No. 3, 2022, approving the sale of property owned by the Lawrence Redevelopment Commission, was read only by title by Clerk Walton. Councilor Chavis assigned Resolution No. 3, 2022 to the Economic Development Committee. The committee will meet on February 23, 2022, at 6pm.

Proposal No. 2, 20220, amending the 2022 civil salary ordinance, was read only by title by Clerk Walton. Councilor Chavis assigned Proposal No. 2, 2022 to the Administration, Budget, and Finance Committee.

Proposal No. 3, 2022, amending the 2022 salary ordinance for appointed officers and employees of the Police Department and the Fire Department, was read only by title by Clerk Walton. Councilor Chavis assigned Proposal No. 3, 2022 to the Administration, Budget, and Finance Committee.

Proposal No. 4, 2022, to appropriate from the ARP Coronavirus Local Fiscal Recovery Fund for purposes that fulfill the intent of the American Rescue Plan Act, was and read only by title by Clerk Walton. Councilor Chavis assigned Proposal No. 4, 2022 to the Administration, Budget, and Finance Committee.

Resolution No. 4, 2022, to adopt a spending plan detailing the use of funding provided under the American Rescue Plan, was read only by title by Clerk Walton. Councilor Chavis assigned Resolution No. 2, 2022 to the Administration, Budget, and Finance Committee.

Resolution No. 5, 2022, recognizing Black History Month, was read only by title by Clerk Walton. Councilor Chavis asked Clerk Walton to highlight ways to celebrate Black History Month. Councilor Chavis moved to adopt Resolution No. 6, 2022. The motion was seconded by Councilor Denney. By a roll call vote, the motion carried unanimously.

Proposal No. 7, 2022, amending the Municipal Code of the City of Lawrence, Indiana regarding employee benefits and overtime, was introduced and read only by title by Clerk Walton. Councilor Chavis assigned Proposal No. 7, 2022 to the Administration, Budget, and Finance Committee.

Councilor Chavis and Councilor Denney discussed Resolution No. 6, 2022 regarding the engagement of Baker Tilly Municipal Advisors, LLC for accounting services to include a cash flow plan. Councilor Denney moved to adopt Resolution No. 6, 2022. The motion was seconded by Councilor Wells. Discussion followed among the councilors prior to the vote. By a roll call vote, the motion carried by the following vote of the Council: Seven (7) aye votes and two (2) nay votes (Councilors Shevlot and Russel).
