Councilor Chavis said there will be a public hearing on Proposal No. 12, 2022 on July 5, 2022, at 6:30 p.m.

Proposal No. 14, 2022, authorizing the City of Lawrence to become a member of the Central Indiana Regional Development Authority pursuant to Ind. Code 36-7.7 et seq, was read only by title by Councilor Chavis. Councilor Chavis said the Committee of the Whole met tonight and recommended a do-pass for Proposal No. 14, 2022. Councilor Denney moved to adopt Proposal No. 14, 2022. The motion was seconded by Councilor Wells. By a roll call vote, the motion carried unanimously.

Resolution No. 11, 2022, adopting a preliminary strategic economic development plan for the Central Indiana Regional Development Authority pursuant to Ind. Code 36-7.7 et seq, was read

Utility Superintendent Salsbery discussed Proposal No. 15, 2022. Councilor Denney moved to adopt Proposal No. 15, 2022. The motion was seconded by Councilor Rusomaroff. By a roll call vote, the motion carried unanimously.
