Council President Lisa Chavis called the meeting to order at 6:30 p.m. and announced a quorum was present.

In her opening comments, Councilor Chavis noted that the majority of the Common Council feels good about the fact that they had passed a balanced budget in the past and had provided pay raises to all city employees. Additionally, pay increases were also provided to public safety personnel using ARP funds despite the negotiations for a zero percent pay increase in their contracts. "Now that's winning!"

After her opening comments, Councilor Chavis read Resolution No. 18, 2021 in its entirety and reported that it will be considered at the next regularly scheduled meeting.

At the conclusion of the public hearing, Councilor Chavis responded to numerous questions about what had changed in the budget process this year. She sited a change in controllers as the primary reason because the lack of clarity stalled the budget process. She repeated that the Council has traditionally supported public safety pay increases. Because of the change in controllers, she said it was difficult to have their questions answered and to obtain information. She said that the Council wants to do the right thing for the right reasons and that Resolution No. 18, 2021, which she read earlier, clearly affirms Council support for public safety.

<u>ADJOURNMENT</u>: There being no further business to come before the Council, the meeting was adjourned at 7:30 p.m., by the unanimous vote of the Council.
