ADMIN UPDATE - January 10, 2017

The annual CMOM Report, required under the City's Agreed Order with the USEPA, is in process of being compiled and prepared for submission to EPA and IDEM.

Well #8 at the Fort well field is being inspected via well-cam in order to determine if the recent damage to the pump and impeller also resulted in damage to the column piping. One defective joint in the column piping has already been detected and this well remains out of service. Total costs are not known at this time, but this has the potential to be a costly repair. The cause of the original damage to the pump and impeller has not been determined at this point.

There are no additional Admin items to report at this time.
