July 11, 2017 - Superintendent's Report

ADMIN UPDATE:

With regard to the question from Ms. Smith regarding the utility's real and apparent water loss calculations, I have checked our data again and found no errors with regard to data entry. As I expressed to her at the last meeting, collecting this information is not an exact science and there is a great deal of estimating that is required because the actual losses cannot be measured. I did check past history and see that in 2015 we averaged 18.8 MG per month in this category of data, in 2015 it dropped to 7.7 MG. 2016 was 10.5 MG and we are presently averaging 9.4MG for 2017. The 2014 data was heavily influenced by a rather heavy main break season due to the freezing temperatures.

In recent years we have made great strides in accounting for various authorized un-billed/unmetered water uses, have installed meters in several locations for metered un-billed usages and also have stepped up customer account reviews and audits in an effort to reduce water losses. While we are not pleased with any amount of water loss, we realize it is a reality that we are not ever going to achieve zero losses.

Our leak survey program did not materialize as hoped for under the last administration due to our inability to purchase the required sensors, although we did purchase the leak correlator (a computer that runs the program that determines the leak location). It should be noted too that this correlator was a "demo" model and we have been having numerous problems with it. It has not performed to our expectations. We are presently reevaluating our approach to system-wide leak survey practices and will be seeking to implement a program that will be effective and cost efficient.
