The month of June saw heavy rainfall yet again with 7.10 inches recorded. We are at 32.4 inches for the year with normal rainfall being about 44 inches. There are still 6 months to go in the year and a wet winter seems to be the forecast. This will mean heavy I&I impacts. There were 4 reported sewer spills for June 2017. Along those lines we have begun laying out sewer projects to get started yet this year with American Structurepoint. This year we will focus on Richardt Street between 48th and 46th in order to clean up this area and also reduce/eliminate sources of clear water. We chose this area because DPW is presently planning a storm water improvement project in this area that will require street excavation. Thus, in order to avoid at some point possibly tearing up new or relatively new pavement, we will seek to correct the sanitary sewer deficiencies in this area. In some area we have two sanitary sewer mains running parallel in the same area for no apparent reason and this is something that would be beneficial to correct. In addition, the sewers in this area are known to have defects needing attention with regard to both sewer main and manholes.

The Utility will also be bringing a Professional Services Agreement to the board at the first meeting in August in order to engage Shrewsberry & Associates to create a Utility Work Plan as is required per official notification from Hanson Professional Services, the engineer for the Franklin Road Reconstruction Project. Per the letter, we are required to have the work plan submitted by October 6, 2017. LU staff has conducted field work necessary to provide in-situ information concerning the water and sanitary sewer assets located within the project area and our preferences for resolution of conflicts. Letters to four contractors seeking to ascertain willingness to provide quotes for the Lawrence Park Ditch Restoration Project were sent out on July 20th. These were sent to Poindexter Excavating, IRE, Inc., Williams Creek and Cardno-JF New. Contractors interested in providing quotes will be provided with the contract specifications and other exhibits electronically. We have asked for expressions of interest by August 4th and our goal is to have this work under contract this year in order to meet the deadline for completion of January 9, 2018.

The plant effluent meter at Indian Lake WTP has been relocated per contractor's recommendation in order to maximize upstream and downstream pipe lengths to improve meter accuracy. This work was accomplished by LU personnel.
