September 12, 2017 - Superintendent's Report

ADMIN UPDATE:

Tonight the Utility will be opening bids for the 2017 Manhole Rehabilitation Project and will turn the bids over to our engineer for review. The Utility management is also seeking to have the USB authorize the Board President or Vice-President to sign the Notice of Award, Notice To Proceed and the Contract outside of a regular board meeting. This authorization is conditioned upon the receipt of all the necessary contract documents, including a Certified Bid Tabulation and letter of recommendation from the project engineer. The selection of the contractor will be based on the lowest, most responsive and most responsible bidder. This is being requested in order to expedite the start date for the contractor as much as possible given the time of year.

The pre-bid meeting with contractors was held on September 6th for the 2017 Manhole Rehabilitation Project. There were some minor questions that arose which will be answered via addendum. We expect there will be at least 2, maybe three contractors bid this project.

The Lawrence Park Ditch Project was assigned to Poindexter Excavating, after their providing the lowest quote to perform the work (\$121,000). This work started the week of September 5th.

The Utility Management is recommending acceptance of the water and sanitary sewer infrastructure installed in conjunction with the Otis Avenue Road Extension Project. The contractor affidavit and inspector's certification of completion and compliance for the installations have been signed and should be in your board packets for tonight's meeting. This acceptance is conditioned upon the receipt of the required 3-year maintenance bonds, which were not received at the time of this report but should be submitted to the Utility in time for this meeting. If the bonds are not received in time we will postpone acceptance until the next meeting.

Work has begun at Richardt WTP with the fence on the north property line being moved and excavation work for the clear well, retention basin and associated piping being started. The contractor for the Sumac water main project is awaiting info from the pipe manufacturer as to the exact date the pipe will be run and shipped and is also waiting on test boring work to be completed prior to construction commencing.
