December 12, 2017 - Superintendent's Report

ADMIN UPDATE:

The Utility is seeking approval for DRF #23 in the amount of \$1,980.00 for loan administration fees to Cornerstone Grant Management. CGM is responsible to monitor all payroll activity with regard to our two active SRF funded projects.

The substantial completion punch-list inspection was conducted on December 4th with the contractor for the Sumac Water Main project along with our inspection team and the project engineer. The punch-list has been provided to the contractor for resolution.

The Utility will be opening bids tonight for the 2017 City of Lawrence Trades District Sanitary Sewer Improvements Project. We anticipate a quick but thorough review of the bids from our engineers and hope to award the contract and issue the Notice of Award at the December 27th meeting.

The Utility management is seeking approval of Change Order #1 on the Richardt Water Treatment Plant. This CO results in a net cost reduction of \$18,270.80. The changes result from review of certain aspects of the plans that were included in the original plans from 2014 as well as some requirements for changes related to the Well Head Protection review by Marion County during the Improvement Location Permit process. Notably, there is a significant deduct related to the Variable Frequency Drives, which were originally called out to be Toshiba. However, after research and evaluation with our engineering team the ABB drives will provide the same level of service performance for considerably less cost. With regard to project fencing, the plans were for the utility to handle the project fencing needs but this would not result in any significant savings and would require coordination amongst the GC and subcontractors that is best handled by the project superintendent for Grave Plumbing.

Richardt:

- Replaced relay for bleach transfer pump.
- Repaired VFD to Well 2

- Fixed bleach line that was leaking by the injector quill in the WTP.
- Removed repair parts and things being stored in electrical room so electrical contractor could begin work in there as part of the new WTP Project.

Oaklandon Tower:

• Enclosed and insulated the tap and water line going to the transducer to prevent freezing.
