Any business located within a wellfield protection area in Marion County is eligible to participate in the free and confidential business assessment program to protect our drinking water.

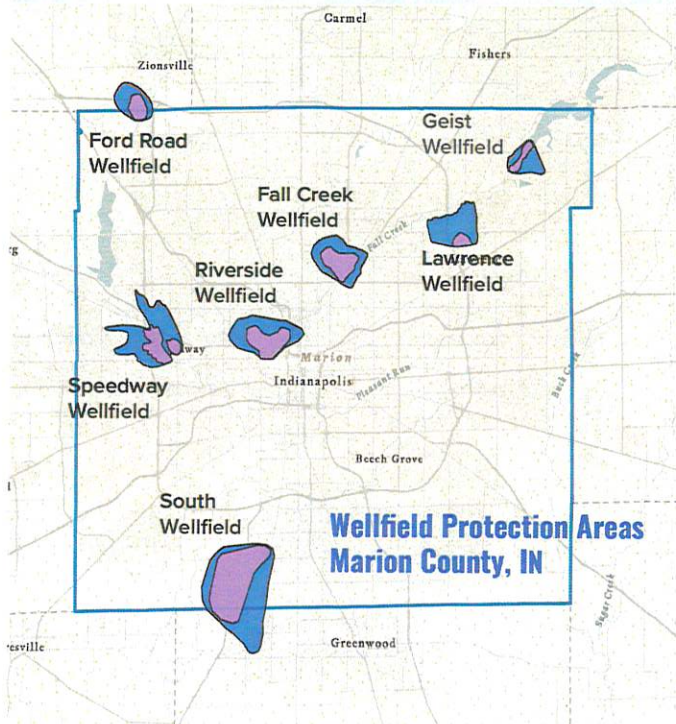
Covered areas include:

WHAT IS AT RISK?

Chemical spills, leaks, and improper storage can lead to pollution of water which seeps into the ground and travels to drinking water wells. The area around a drinking water well is known as a wellfield protection area. Businesses in wellfield protection areas are required to follow the Marion County Public Health Department's Wellfield Protection Code.



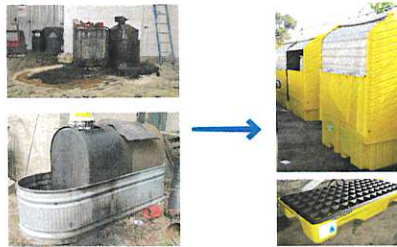
WHAT CAN I DO?
