ADMIN UPDATE:

We are seeking approval of a General Observation Agreement between the Utilities and Goodwill at Geist Project for potable water mains and appurtenances. This agreement is for the City (Utilities) to provide general construction observation services consisting of periodic on-site physical review of construction and materials including pre-filling and final completion inspections and all other needed services mentioned in the agreement at a rate of \$75.00 hour for an estimated total fee of \$1,200.00.

We are seeking approval of Resolution No. 3, 2025; A Resolution of the Utility Service Board Declaring Certain Property to be Surplus and Authorizing Disposal. Items include:

We are seeking approval of the Non-Exclusive Sanitary Sewer Utility Easement granted by DNR to the City of Lawrence Utility Service Board for the purpose of replacing and relocating a failing sanitary sewer main located along Shafter Road at the entrance to Fort Harrison State Park. This easement is necessary and related to the Fort Harrison Sanitary Sewer Improvements Project Phase III that the Utility is currently working on with Clark Dietz, Inc. (engineering) to replace and relocate the sanitary sewer main and manholes along Shafter Road that are in disrepair due to age, depth, and condition that are allowing the entry of Inflow and Infiltration as well as pose a danger of pipe failure that could result in loss of service and a sanitary sewer overflow.

The design of this project is complete and advertisements to invite sealed bids from contractors are scheduled to be posted in the Indy Star on May 14, 2025, and May 21, 2025, with a bid opening date of June 12, 2025.
