 - a. To be continued to April 24, 2025 Agenda.

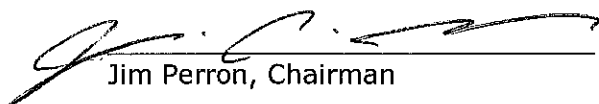
New Business:
