# CITY OF LAWRENCE Common Council May 21, 2025 Regular Meeting

President Cramer called the meeting to order at 6:40 p.m.

The pledge of allegiance was administered, followed by a moment of silence.

President Cramer recognized there was a quorum. It was also recognized there were extra copies of the agenda located at the back of the room along with a sign-up sheet for comments from the citizens.

<u>COMMENTS OF COUNCIL MEMBERS</u>: Councilor Wells addressed the council with the following comments:

- Numerous citizen complaints have been received regarding youths riding motorcycles and minibikes in Harrison Park and Lawrence Park.
- These are **not mopeds**, but full motorcycles being ridden unsafely including **doing wheelies** and **running stop signs** (notably at **50th and Patton and Barlo**).
- Councilor Wells witnessed the behavior firsthand and contacted the police, who responded and confronted one of the individuals.
- The officer cited the rider's helmet use and 50cc engine size as justification for not taking action.
- Councilor Wells disagreed, referencing **Indiana Code** which restricts such vehicles on sidewalks and public spaces, regardless of engine size.
- Councilor Wells contacted the Chief of Staff, Chief Bigsbee, and Director of Operations Officer Romeril, who acknowledged the illegality but suggested such behavior was considered less criminal and thus received lower enforcement priority.
- Specific concerns included:
- Noise issues due to tampered exhaust systems.

- Safety risks, including a reported accident in which a child hit a car and sustained a broken arm.
- Councilor Wells emphasized **sympathy for constituents' concerns** and frustration with the current enforcement stance, noting that enforcement is at the **discretion of individual officers**.
- He concluded by stating that while he has taken action to address the issue, further outcomes are uncertain.

# APPROVAL OF MINUTES REGULAR MEETING 5-5-2025

Councilor Giles made a motion to approve the minutes. Councilor Jennings 2<sup>nd</sup> the motion. Vote was taken. Motion carried unanimously.

- Discussion: Contract for city engineering services.
- Action: The committee unanimously recommended approval of the contract with United Consulting.

- The committee returned a favorable recommendation.

### Discussion:

- Councilor Wells inquired whether an RFQ was issued to other law firms.
  - Response: No RFQ was issued; historically, one has never been required for legal counsel selection.
- Councilor Wells also asked whether the scope of the contract includes services beyond attendance at two council meetings.

 Response: Yes, given by Scott Krapf, of Frost Brown Todd. The flat fee covers additional services, which were outlined in the engagement letter provided to all council members.

2) Resolution No. 5, 2025 – A Non-Binding Resolution Of The Common Council Of The City Of Lawrence, Indiana, Recognizing The Month Of May As Mental Health Awareness Month.

### Summary:

The resolution outlines the importance of mental health, recognizes the stigma and barriers surrounding mental illness, and calls for increased awareness, support, and resources in the City of Lawrence.

<u>COMMENTS FROM THE ADMINISTRATION:</u> Jamie Weirich, Director of Communications & City Events, provided all with the following announcements:

- Farmers Market: Begins June 5th and runs through October 2nd, every Thursday from 4 PM to 7 PM. A total of 18 markets will be held.
- Juneteenth Jubilee: Scheduled for June 21st from 4 PM to 8 PM at the Fort Ben Cultural Campus.

<u>CITIZENS COMMENTS:</u> **Colleen Morgan** (8140 Patton Drive, Harrison Park): Raised concerns about motorized bikes using the walking trail near her property. She noted excessive speed, noise, unsafe behaviors (e.g., no helmets, performing stunts), and the danger posed to pedestrians.

**Stacy Eleck** (8121 East 50th Street): Shared additional concerns regarding the safety hazards of young children riding mini-bikes and dirt bikes in the neighborhood. Mentioned unsafe traffic behaviors and potential accidents due to limited visibility and speeding vehicles.

**Daniel Rapp** (5718 Wallingwood Drive): Voiced concern over the **Form 1 Budget Document** posted for 2025, specifically the lack of revenue figures. He questioned whether the published budget is balanced and urged the council and administration to clearly communicate the city's revenue figures. Mr. Rapp emphasized the importance of transparency and fiscal responsibility.

<u>ADJOURNMENT</u>: Councilor Cramer called for adjournment. There being no further business to come before the Council, the meeting was adjourned at 7:08 p.m., by President Cramer.
