 Mayoral Veto – Proposal No. 2, 2025 An ordinance of the Common Council of the City of Lawrence, Indiana, amending Title 1, Article 1, Chapter 2, Section 12 of the Municipal Code regarding Common Council approval on expenditures of professional service contracts.

The ordinance was previously passed but deemed **vetoed** due to lack of timely approval by the mayor.

• Proposal No. 7, 2025

An Ordinance of the Common Council of the City of Lawrence, Indiana Adopting a Code of Ethics. Referred to the Code Committee for consideration.

QUESTIONS FOR THE ADMINISTRATION:

- Councilor Cramer expressed concerns regarding:
 - o The recent budget presentation by the mayor lacking council interaction.
 - o The live stream and audio being shut off during the session.
 - o The administration was reminded that the Council President determines adjournment of meetings.

Clarifications provided by Greg Goodnight

- o The meeting was an administrative presentation, not a regular council meeting, hence no roll call or pledge.
- o The meeting format was in line with other cities' mayoral addresses.

Comments from Council President

The importance of collaboration and communication between the administration and the Council regarding meeting scheduling.

- Councilor Giles initiated discussion on:
 - o The **deficit budget** ranging between \$1.3 to \$3 million.
 - o Potential need to **pause hiring**, including within public safety.
 - Emphasized the Council's commitment to transparency and difficult fiscal decisions.

Councilor Wells:

- o Stressed the limited time available to review and cut the budget.
- Expressed frustration over delayed delivery of the budget compared to other cities.

• President's Remarks:

- Encouraged public feedback to be shared respectfully and in person during meetings.
- Reiterated the need for timely and cooperative engagement from the administration.
- Councilor Wells inquired about upcoming grants:
 - Administration noted significant cuts at the federal level, but no specific grants were cited.
 - Grant Writer, Jim Perron, indicated a report would be prepared for the Council.
- Councilors requested clarification on:
 - o **Internal service charges** in the budget, especially within the police department.
 - Explanation: Previously funded by ARPA; now moved into the regular budget.
 - Timing and content of the salary ordinance expected in upcoming meetings.
 - Concerns about retirement-related payouts and budget forecasting were discussed.

<u>CITIZENS' COMMENTS:</u> Citizens' Comments (*Limited to 3 minutes per speaker*)

- Daniel Rapp (5718 Wallingwood Drive):
 - Addressed inconsistencies and formatting issues in financial reports (April– June 2025).
 - Questioned unauthorized budget amendments appearing in reports without Council approval.
 - o Urged residents to review financials and attend budget meetings.

<u>ADJOURNMENT</u>: Councilor Robinson called for adjournment. There being no further business to come before the Council, the meeting was adjourned at 7:30 p.m., by President Robinson.
