Council President Zach Cramer called the meeting to order at 6:34 p.m.

The pledge of allegiance was administered, followed by a moment of silence.

Roll call was taken. Seven (7) council members were present. President Cramer recognized there was a quorum. A quorum was confirmed.

COMMENTS OF COUNCIL MEMBERS AND SPECIAL RECOGNITIONS OR RESOLUTIONS:

Councilor Freeman

- Raised concerns regarding a long-closed go-kart facility on Post Road (approx. 4544 Post Road).
- Reported visible code violations include trash, damaged fencing, and potential unauthorized access.
- Requested review by the Code Enforcement Department.

Councilor Wells

- Discussed concerns regarding the proliferation of mobile food vendors and their impact on brick-and-mortar restaurants.
- Shared research and communication with the Marion County Board of Health.
- Noted that permitting fees go to Indianapolis, not the City of Lawrence.
- Explained requirements for mobile food vendors, including a compliant home base, sanitation, and inspections.
- Referenced Indiana Senate Bill 1577, effective next year, shifting oversight of food trucks to the State of Indiana.

- Expressed concern about enforcement, economic fairness, and the effectiveness of hired lobbyists.
- Requested a potential presentation to Council by a Board of Health representative.

Chief of Staff, Greg Goodnight addressed questions from earlier in the meeting:

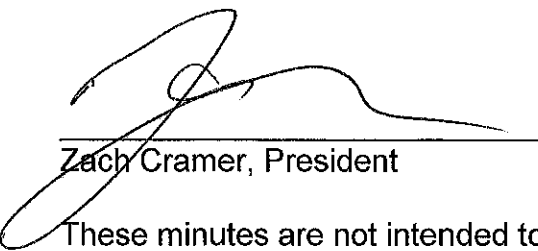
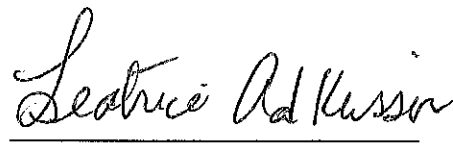
- Administration acknowledged concerns regarding food trucks.
